- 1 Maximum age limit 50 years at the time of submission of On-Line application.
- 2 The candidate must submit minimum 01 month driving training certificate towards competence to drive the bus including the skill test as conducted by either driving training institute Burari or IDTR Loni Road (alongwith application).
- 3 The selected female candidate must undergo the two months driving training followed by and skill test certification from DTC before allowing them to operate on road.
- 4 The selected female candidate will be governed by terms and conditions of their contractual appointment available at **Annexture-A**.
- A sum of Rs. 12000/- will be paid to the female drivers as stipend during training period subject to 25 days attendance.
- 6 Physical Standard: Height Minimum = 153 Cms. for female driver.
- 7 The candidates not having valid PSV Badge issued by STA at the time of applying for the post of driver are required to submit Valid PSV Badge issued by STA, Delhi within one month of issuance order of their posting.
  - 8 The candidate must identify and understood of various signs as stipulated in Motor Vehicle Rule-1989 which are being used for making a discipline on the road.

- (a) Incentive will be paid for line duties to the contractual drivers who are deployed on buses only.
- (b) There should not be any fatal/major accident on the part of contractual driver for payment of incentives in the relevant month.
- 5. The total emoluments worked out as above shall be paid to the 2<sup>nd</sup> party. In addition to the emoluments, the statutory contribution at the prescribed rates shall also be made by the first party towards employers share on account of the Employees State Insurance (ESI) and Provident Fund (P.F) contributions respectively.
- 6. The 1st Party will deduct all the statutory deductions as per the laid down rates from time to time.
- 7. The 1st Party reserves the right to cancel the Agreement or to terminate the services of the 2nd Party without giving any notice/reason.
- 8. In case of accidents/court cases, the 2nd party shall arrange for his security as well as for his bail in case of his arrest. No wages shall be payable for the period under arrest. The 1st party reserves the right to decide whether the 2nd party should be allowed to continue in employment.
- 9. The 2<sup>nd</sup> Party shall indemnify the 1st Party against all damages I charges and expenses for which the 1<sup>st</sup> Party may be held liable to pay on account of negligence of the 2<sup>nd</sup> Party or any person under his control whether in respect of accident, injury or damage to the person or the property of any member of the public or any person or in executing the work or otherwise and against all claims and demands thereof which includes demands of 1st Party also.

- 10. If any information furnished by 2<sup>nd</sup> Party is found to be incorrect at any time, the Agreement is liable to be terminated without any notice.
- 11. The 2nd Party shall compensate in full or in part as decided by the 1st Party, the loss sustained by the 1st Party on account of losses resulting from any damage/fraudulent tactics put to the 1st Party by 2nd Party or in case of concealment of facts regarding age, driving skill, imprisonment / fine by the Court of Law etc. Which may lead to termination or this Agreement also.
- 12. That the 1<sup>st</sup> Party shall have the right to utilize the services of the 2<sup>nd</sup> Party. In any of the depots / units of the 1st Party.
- 13. The 2<sup>nd</sup> Party should be (i) 10<sup>th</sup> passed or equivalent from any recognized Board/Institute in India) (ii) Maximum age limit is less than 50 years on the date of conducting interview, In any case, No driver can work beyond 60 years (iii) Holding a valid Heavy Motor Vehicle License for at least 3 years old and PSV badge issued by STA-Delhi (as per criteria/conditions applicable to commercial drivers of PSV for issue of "Authorization Cards" for Heavy Motor Vehicle Drivers.
- 14. The 2<sup>nd</sup> Party shall wear the prescribed Uniform according to the season, i.e., Summer/Winter Uniform in Summer/Winter seasons and a badge bearing his name& designation. While on duty.
- 15. The 2<sup>nd</sup> party be issued temporary identity card-cum-free destination pass for DTC buses by the 1<sup>st</sup> party within the Union Territory of Delhi, from the residence to the duty place and Vice-versa for a period of one year which will be renewed on one year basis.
- 16. The 1<sup>ST</sup> Party shall terminate the services of the 2nd Party in case of blacklisting on account of fatal accident or any other nature of committal of offence/serious misconduct or not found to be competent or found to be disorderly in the discharge of his duties.
- 17. The nature of the engagement of the 2nd Party is purely on contractual basis and he shall not raise any claim for seniority, regularization of services on permanent basis in DTC at any point of time. In case the 2nd Party do so, the 1st Party will be at liberty to take necessary action as deemed fit including termination of the contract. Further the services of the 2nd party can be terminated at any time as per the staff position existant at that time.
- 18. The 1st Party shall have full right to conduct physical/medical examination and training from DTC Trg. School in respect of 2<sup>nd</sup> Party before his engagement as contractual driver on short-term basis.
- 19. The 1st Party shall be authorized to fix timings of the various duty shifts. A single duty shift will have normal duration job of 8 ½ hours including rest of half an hour.
- 20. The 2<sup>nd</sup> Party shall be bound to observe all the instructions issued by the 1<sup>st</sup> Party concerning general Discipline and behavior.
- 21. The Duties and Responsibilities of the 2nd Party are as under: -
- a) He shall ply the bus as per prescribed memo issued to him by the 1st Party.
- b) He shall not leave the bus isolated while on rest in his duty hours.
- c) He shall ensure that all the instructions of the 1st Party are strictly followed and there is no lapse of any kind.
- d) He shall be well behaved and disciplined towards the commuters who travel in the bus.
- f) He shall stop the bus at the proper bus-stand and let off and take the commuter's properly on each bus stop.
- g) He shall follow all traffic rules; ply the bus within permissible speed limit and in the bus lane.

- 22. Any violation of the above duties reported to the authorities will result into cancellation of contract forthwith.
- 23. Any other provisions as advised by the 1st Party shall be incorporated in the Agreement. The same shall also be the binding on the 2<sup>nd</sup> Party.
- 24. The 1<sup>st</sup> party shall terminate the contract agreement of the 2<sup>nd</sup> party without notice in case 2<sup>nd</sup> party is found to be having directly or indirectly engaged/associated in/ with any other business, occupation or employment including driving etc. against the interest/work of the corporation.
- 25. the first party shall have the right to forfeit/cancel the license if 2<sup>nd</sup> parties have indulged in leakage to traffic revenue on line whereby not even a single ticket has issued in the bus although the passengers have paid the due fare also the bus has also found driven by an authorized person.
